- * Residents must deposit waste and recyclable items in designated areas. Waste deposited should have been generated in Jocelyn Township and **NOT** from outside the Municipality

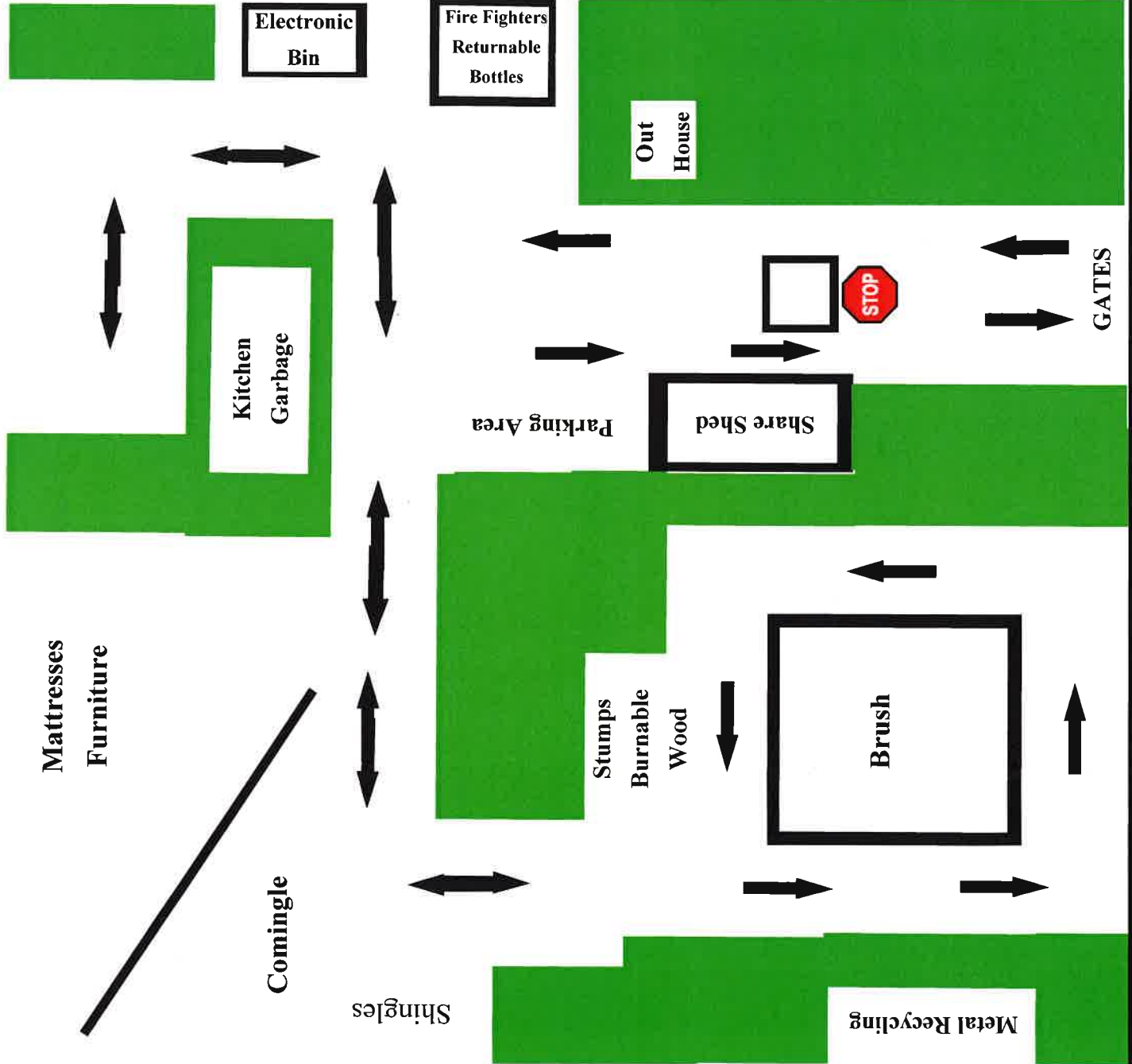

ACCEPTED ITEMS:

Kitchen garbage (household refuse) - *Household garbage area*

Stumps - *Stump area*

Brush - *Brush-burn pile area*

Local Shingles - *Shingle area*

Local Construction material - *Comingle (miscellaneous) and/or wood pile areas*

Mattresses/furniture - *Comingle (miscellaneous) area*

Scrap metal - *Metal area (no scavenging)*

Leaf and yard waste (grass) - *Wood pile area*

Cardboard - *Comingle (miscellaneous) area and Recycling bins at corner of Hwy 548 and Hwy 17*

Carpet - *Comingle (miscellaneous) area*

Pressure treated wood - *Comingle (miscellaneous) area (no scavenging)*

Glass - *Comingle (miscellaneous) area (do not drop in the unloading area - set back to edge as close as possible)*

Waste Electronic and Electrical Equipment - *Electronic Bin (list of accepted items on bin)*

Each type of non-household refuse must be separated and placed in designated areas.

Household refuse must be separated from recyclable items and non-household refuse.

Household refuse is to be thrown OVER bank in designated area.

NOT ACCEPTED (not a complete list)

- *Tires
- *Car bodies, Recreational vehicles, Farm machinery
- * Antifreeze
- *No paint or paint cans
- *Solvents/ thinners/aerosol cans
- *Motor oil
- * Herbicides/Pesticides
- *Propane tanks/ Oxygen tanks/Fire extinguishers
- *Ammunition/Fireworks/Explosives
- *Compact fluorescent light bulbs
- *Gasoline/fuel/kerosene
- *Pool chemicals
- *Railway ties
- *Radioactive, Biomedical, or unidentified waste
- * Mercury
- * Printer cartridges
- * Pharmaceuticals

New- Freon Capture Program

Refrigerators, freezers or air conditioners will be accepted once a Freon Voucher is purchased at the Jocelyn Township Office at a cost of \$35. NO vouchers will be sold at the Landfill

Working refrigerators, freezers or air conditioners will not be accepted at the Share Shed.

BATTERIES

(AAA, AA, C, D, BUTTON CELL AND 6 & 9 VOLT)

Single-use batteries can be recycled and dropped off at the Landfill Share Shed or Jocelyn Township Office. Tape the positive terminal ends on the batteries to reduce any risk of short-circuit. A list of batteries and additional information can be found on www.rawmaterials.com

Fundraising

Pop cans, Canadian beer cans & bottles, liquor & wine bottles are being accepted at the Jocelyn Fire Association's bin located at the Landfill.

LANDFILL TICKET

Each property owner will receive one ticket with Interim Tax Bill. Your ticket is good for one free day of tipping. Does not include Contractor material or demolitions.

Tipping fees can be paid at the Township Office

- 1/2 Ton - \$10.00
- Utility Trailer - single axle - \$10.00
- Utility Trailer - double axle - \$20.00
- One Ton/Double axle trailer - \$20.00
- One Ton - \$20.00
- Dual Axel - \$100.00
- Tri-Axel - \$125.00
- Commercial Dumpster - \$125-\$175.00
- Shingles double above prices
- Batteries - NOT ALLOWED
- Tires - NOT ALLOWED
- Other Appliances - No Charge
